All food, beverages & alcohol will be purchased through Heritage Hill Golf Course or The Back Nine Pub. We do not allow personal coolers.

We can accommodate extra non-golfers for meals after the golf outing if needed.

Any violation of the listed Back Nine Club’s policies will result in forfeiture of the \$300 deposit.

The outing fee for Monday – Thursday is \$48.00 per golfer includes Greens Fee, Cart Fee.

The outing fee for Friday, Saturday, Sunday, and Holidays is \$50.00 per golfer includes Greens fee, Cart Fee.

Maximum Number of Golfers is 84 riders. Our hosting can accommodate over 100 people, but over 84 will either have to walk at a discounted rate or be sent out as a separate group earlier.

Final count and menu selection are due 10 days prior to your event. Pairings will be submitted at least 6 days prior to your event (e-mailed pairings are preferred). Any sponsor signs will be brought to the Heritage Hill Club the night before your event.

****Payment for a minimum of 60 golfers is required to close the course.** (Signature authorizes credit card to be charged for final count player participation at rates listed above.) Under the discretion of the management team, start times will be determined to maximize course efficiencies.

All players are required to wear appropriate golf attire. Each golfer should have their own set of golf clubs. Rentals clubs are available with prior notice. **Absolutely, no alcohol beverages (jello shots etc.) or food can be brought in from the outside.**

The Superintendent or the Head Golf Professional are the sole individuals who can declare the course to be unplayable. Cancellation for “inclement weather” is not permitted after final payment. The outing will be rescheduled for a later date if unplayable.

Successful preparation and planning are essential to The Back Nine Club providing a superior outing experience. The above-named outing has read this agreement and agrees to be 100% compliant with all terms listed above. All players and others at the course/clubhouse assume all risk of injury to themselves, damage and/or loss of property. All players are liable for their acts to all/other persons while on property. The Outing takes responsibility for informing each participant of these rules and responsibilities.
